# Care Coordination

A Care Coordinator provides ongoing support and referrals to support individuals in their community

Available in Community Connect and Free Through Recovery, as well as through the 1915(i) Medicaid State Plan Amendment

# Peer Support

Peer support specialists bring hope by sharing their experiences and promoting a sense of belonging.

- Establish positive rapport.
- Serve as a role model.
- Offer insight to the individual's care team.
- Provide support focused on advocacy, coaching, and mentoring.
- Available in Free Through Recovery, Community Connect, 1915(i), Recovery Talk, Call Kay, Human Service Centers, Parent Coordinators, Private Providers, Prisons and growing!

# Certification

► The Behavioral Health Division currently certifies peer support specialists

There is no certification for Care Coordinators, however each provider agreement that employs Care Coordinators has requirements

CommunityConnect My Recovery. My Story. Community Connect is designed to meet the needs of individuals through Care Coordination, Peer Support and Recovery Services

- North Dakota Resident
- ▶ 18 years or older
- Functional Impairment in areas such as housing, parenting, physical health or community connections
- Community Connect | DHS Behavioral Health Division (nd.gov)

Application for eligibility is available online. Upon approval, the applicant is notified and if selected provider the referral is sent to provider and services may start. Alternate contact, point of contact is on application as well.

# FREE THROUGH Recovery

Free Through Recovery (FTR) is a community based behavioral health program designed to increase recovery support services to individuals involved with the criminal justice system who have behavioral health concerns.

- Referral is made from their state probation or parole officer
- If you have contact with a person that is on DOCR(state) supervision who would benefit from FTR, contact their probation or parole officer for a referral.
- Individuals on federal supervision do not qualify, but they may utilize Community Connect

# Mental Health Program Registry

### Phase 1-In progress, Mental Health Programs begin to register

For the purpose of this registry, a Mental Health Program is:

- An agency/organization that provides mental health services by a licensed mental health professional
- Individually licensed mental health professionals that operate as a sole proprietor (business)

A licensed mental health professional for purposes of this registry includes:

- Professional Counselors
- Marriage and Family Therapists
- Clinical Psychologists
- Psychiatrists
- Advanced Practice Registered Nurse-Mental Health
- Clinical Social Worker

Phase 2-Front facing website becomes available in September with a directory/search feature to find a mental health program.

## Substance Use Disorder (SUD) Voucher Program

During the 64th Legislative Session the Department of Human Services (DHS) was appropriated funding to administer a voucher system to pay for substance use disorder treatment services.

## Goal 1

Allow individual to choose provider

Objective 1.1 Increase number of providers and service options.

Objective 1.2 Service options are communicated to individuals. Goal 2

### Improve access to quality services

Objective 2.1 SUD Voucher providers provide evidencebased services based on individual need.

Objective 2.2 Reduce financial barriers for individuals accessing needed services.

# Eligibility Requirements

The individual's **Federal Poverty Level (FPL) is below 200%** (An exception request can be submitted and is reviewed on case-by-case basis)

The individual is at least **14** 

years old

The individual is currently a **ND resident** 

The individual lacks resources to cover cost of treatment

## **Covered Services**

Since the program's inception, approximately 4,200 individuals have received services through the SUD Voucher.

# Future state of how 988 will fit with other resources

988 Suicide and Crisis Lifeline (replaces the 1-800 suicide prevention line & 211 crisis line; although all numbers will direct callers to the same place)		211	911			
Who contacts	Individuals experiencing suicidal, mental health and/or substance use crisis	Individuals looking for help meeting basic needs like housing, food, transportation and healthcare	Individuals experiencing an emergency			
Who answers	Crisis Support Specialists (trained in crisis intervention)	Resource Specialists (trained in local community resources)	Emergency Dispatchers (trained to assist callers through emergencies)			
What is offered	Emotional support to de-escalate situation and may refer/dispatch to mobile behavioral health crisis support	Information and referrals	Obtain information in order to dispatch the right responders to the right location, may provider instruction until responders arrive			

The suicide hotline and 211 for crisis will temporarily remain as active and all calls will continue to be answered by the central call center (FirstLink).

# How does 988 work?

When an individual calls **211**, it is routed to a call center based on the <u>cell phone</u>

### <u>tower</u>

 When routed to North Dakota FirstLink, if all lines are busy, the individual will be put on hold until a line is open When an individual calls **988**, it is routed based on the individual's <u>cell phone area</u> <u>code number</u>

When routed to North
 Dakota FirstLink, if all lines
 are busy, the individual will
 be routed to another back-up
 center outside of North
 Dakota

When an individual **texts 988 or chats** at <u>Lifeline Chat :</u> <u>Lifeline (988lifeline.org)</u>, it is answered by an out-of-state lifeline provider. FirstLink is building capacity to be able to answer 988 chats in the future.



# How does 988 work?

FirstLink provides suicide risk assessment, de-scalation, support

If needed, FirstLink connects to the local Human Service Center mobile crisis team.

• HSC's mobile crisis teams are currently available at all 8 locations.

This process is unchanged from the pre-988 transition.

# Recovery Housing

Recovery Housing refers to safe, healthy, and substance-free living environments that support individuals in recovery from addiction. While recovery residences vary widely in structure, all are centered on peer support and a connection to services that promote long-term recovery.

The Recovery Housing Program offers up to 12 weeks of Recovery Housing rent expenses for eligible, enrolled individuals.

For individuals to be eligible, they must meet the following criteria:

- ND Resident and
- Age 18 or older <u>and</u>
- Experiencing a substance use disorder <u>and</u>
- One of the following:
  - Currently enrolled in a Department of Human Services Public Assistance Program or
  - Currently enrolled in a Behavioral Health Division substance use disorder or community program or
  - Household income is at or below 200% Federal Poverty Guidelines



# 1915(I) Home and Community Based Services



- Amendment to the ND Medicaid State Plan
- Designed to fill gaps in the Behavioral Health Services delivery system identified in the 2018 HSRI report

# 1915(i) Services

# 1915(i) Eligibility Criteria

- 1. The individual is **age 0+**; and
- 2. The individual is currently **enrolled in ND Medicaid or Medicaid Expansion**; and
- 3. The individual's household income is at or below **150% of the Federal Poverty Level (FPL)**
- 4. The individual has a **qualifying substance use, mental health or brain injury diagnosis**; and
- 5. The individual has a WHODAS score of 25 or above; and
- 6. The individual resides in and will receive services in a setting meeting the federal **home and community-based setting** requirements

# 1915(i) Enrollment

- 2. Submit Enrollment Application Form to Human Service Zone
- 3. Choose a Care Coordination Agency


